

# Annual Assessment Reports

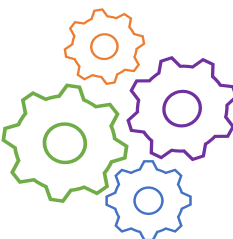
Annual reporting requirement for all academic programs

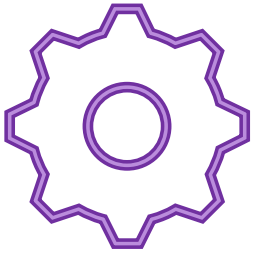
- Outline outcomes scheduled to be assessed in that year
- Describe assessment measures and targets
- Share data and findings
- Action plans if targets are not met
- Outline activities that support ongoing program improvement and student learning

**Due October 1<sup>st</sup>**

Degree programs and certificates are reported on separately

Component of HLC criterion 4B





# Academic Program Review

**Completed every 5-8 years** – separate reporting for degree programs and certificates

UND APR Self-Study includes:

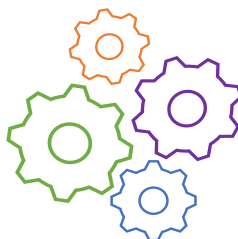
- Alignment to mission of college/university
- Progress since previous APR
- Student learning outcomes assessment results and actions
- Faculty activities and scholarship
- Enrollment and retention trends
- Curriculum
- Overall program analysis

Self-Study due **October 15<sup>th</sup>** of the assigned year

Component of HLC criterion 4B and 4A1

**Review Process:**

1. College Review Team
2. External Reviewer(s)
3. Academic Dean
4. VPAA



## Annual Assessment Reports

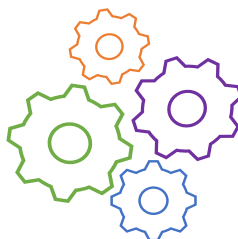
- Annual requirement
- Due October 1st
- Focuses only on assessment of student learning
- Identify learning outcomes assessed that year (cycle) and the data/findings/action steps
- Reviewed by University Assessment Committee

## Academic Program Review

- Completed every 5-8 years
- Self-Study due October 15th
- Comprehensive review
- Longitudinal assessment results compiled as part of the report
- Multi-step review process

## Both Processes

- Evaluate academic degree programs and certificate programs separately
- Reference assessment of student learning
- Utilize Watermark Planning & Self-Study as online repository
- Required component to maintain accreditation from the Higher Learning Commission





# External / Specialized Accreditation

If applicable

External accrediting agencies that have their own standards, guidelines and timelines for re-accreditation.

Examples:

NASM – National Association of Schools of Music

CAEP – Council for the Accreditation of Educator Preparation

ABET – Accreditation Board for Engineering and Technology

External accreditation work usually completed within the college/department.

Academic Program Review will align with External Accreditations as best as possible.





# Essential Studies Assessment

If applicable

## Course-level Assessment

Courses that have been validated as meeting the student learning outcomes with an Essential Studies goals

- Critical Inquiry & Analysis
- Quantitative Reasoning
- Written Communication
- Oral Communication
- Information Literacy
- Intercultural Knowledge & Skills

Essential Studies Assessment occurs using the AAC&U VALUE Rubrics

Each goal is assessed on a rotating basis





# Continuous Improvement

Actions based on assessment results.

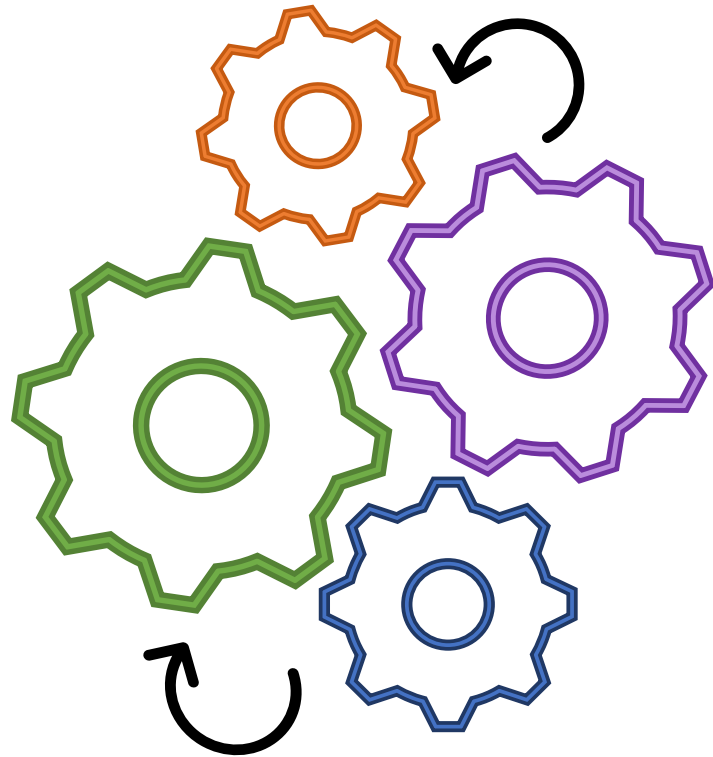
Use information to improve student learning.
